



## **FBU: Teacher Training Waiver, Disclosures, & Financial Details**

### **Waivers & Disclosure Information:**

#### **Liability Waiver**

- A standard "Voluntary Agreement of Participation and Waiver of Liability" must be signed by every program participant.

#### **Down Payment/Full Payment/Refund Policy - For All Programs**

- After initial application is completed and accepted, you will receive an emailed link for the required **\$500** non-refundable deposit and registration form to be completed within 72 hours of email.
- The balance of the **FBU: Teacher Training Intensive** must be paid in full by the specified Paid in Full Date.
- Early Bird Total Tuition Rates are valid only by the specified Early Bird date, and only if tuition is Paid in Full.
- Incomplete payments will forfeit registration and the space may be given to another student.
- Payment plans are available in a case by case basis by contacting [michele@yogahothouse.com](mailto:michele@yogahothouse.com). All payment plans will incur a \$99 administrative fee.
- Initial \$500 Deposit is non-refundable. Additional tuition payments are refundable up to 30 days before the beginning of the registered training session. After this date, no refunds will be issued.
- In the unlikely event that the training is cancelled The Funky Buddha Yoga Hothouse will refund 100% of your tuition payments.
- Funky Buddha is not to be held liable for flight/travel costs or any additional expenses, including but not limited to: lodging, food, parking, etc.

- FBU: 200 Hour Teacher Training – Winter Session

*The Winter FBU: 200 Hour Teacher Training is a weekend program, consisting of 9 weekends over 3 months (January-March, beginning January 13, 2019, ending March 16<sup>th</sup>, 2019). The schedule will run each month for 5 consecutive weekends, with a one-week break, and then continue for 3 additional weeks, ending on March 16, 2019.*

## **Attendance Policy**

In order to be eligible for Yoga Alliance 200-hour certification, strict program attendance is required. For every 1-4 hours missed you will need to schedule a one-hour private session, at a cost of \$150. For every 4-8 hours missed, you will need to schedule a 2-hour private session, at a cost of \$250. The maximum amount of days missed can be no more than two days (16 hours) for a complete 200 Hour Training / 1 day (8 hours) for a 100 Hour Training. There will be No Refunds issued for failure to complete the registered training.

## **Yoga Alliance 200 Hour Certification**

200 Hour RYT (Registered Yoga Teacher) Certification is granted through Yoga Alliance, the governing body of Yoga in the United States. The **FBU: Teacher Training Intensive** fulfills and exceeds all 200-hour curriculum requirements, as dictated by Yoga Alliance. However, in order to obtain a 200 Hour RYT Certification, graduates of the FBU: Teacher Training Intensive will be required to personally submit their certificate of program completion to Yoga Alliance. Applicants will be responsible for the completion of all additional Yoga Alliance Requirements (ie: live teaching time, etc.) and all fees associated with their Yoga Alliance 200 Hour RYT Certification.

## **Potential Employment at the Funky Buddha Yoga Hothouse**

**Graduation from a FBU 200 Hour Teacher Training** is a pre-requisite for acceptance into our **FBU: Teacher Mentorship Program**, and participation is encouraged for those that are considering a career with the Funky Buddha Yoga Hothouse.

However, completion of the FBU: Teacher Training Intensive in *no way* guarantees a position in our Teacher Mentorship Program or employment by the Funky Buddha Yoga Hothouse in any capacity.

All Staff Teachers at the Funky Buddha Yoga Hothouse are trained through the **FBU: Funky Buddha Mentorship Program**. Participants in the FBU: Teacher Mentorship Program are carefully selected via a rigorous and multi-layered application and interview process, which takes into consideration many factors, including but not limited to: Funky Buddha Core Values & Culture match, skill level, trainability, & studio needs.
